2024 Navajo Nation Opioid Awareness Summit

Deadline: August 12, 2024

The Navajo Nation Division of Behavioral and Mental Health Services (DBMHS), through the Center of Harmony and Recovery (COHR), is hosting the 2024 Navajo Nation Opioid Summit to address the growing opioid crisis and enhance public education on harm reduction, prevention, treatment and recovery options. The summit is scheduled for September 24-25, 2024, at the Navajo Nation Museum, in Window Rock, Arizona.

COHR, Tribal Opioid Response Program, is seeking proposals from clinicians, recovery specialists, medical professionals, criminal justice professionals, researchers, and other stakeholders who have experience in opioid use disorder. We invite interested individuals to submit a proposal to share evidence-based approaches to harm reduction, prevention, treatment, the recovery process, overcoming stigma, and integrative care coordination.

The agenda will include breakout sessions between 50-60 minutes and keynote speakers/general sessions between 60-90 minutes; however, this is subject to change depending on the number and type of proposals received.
